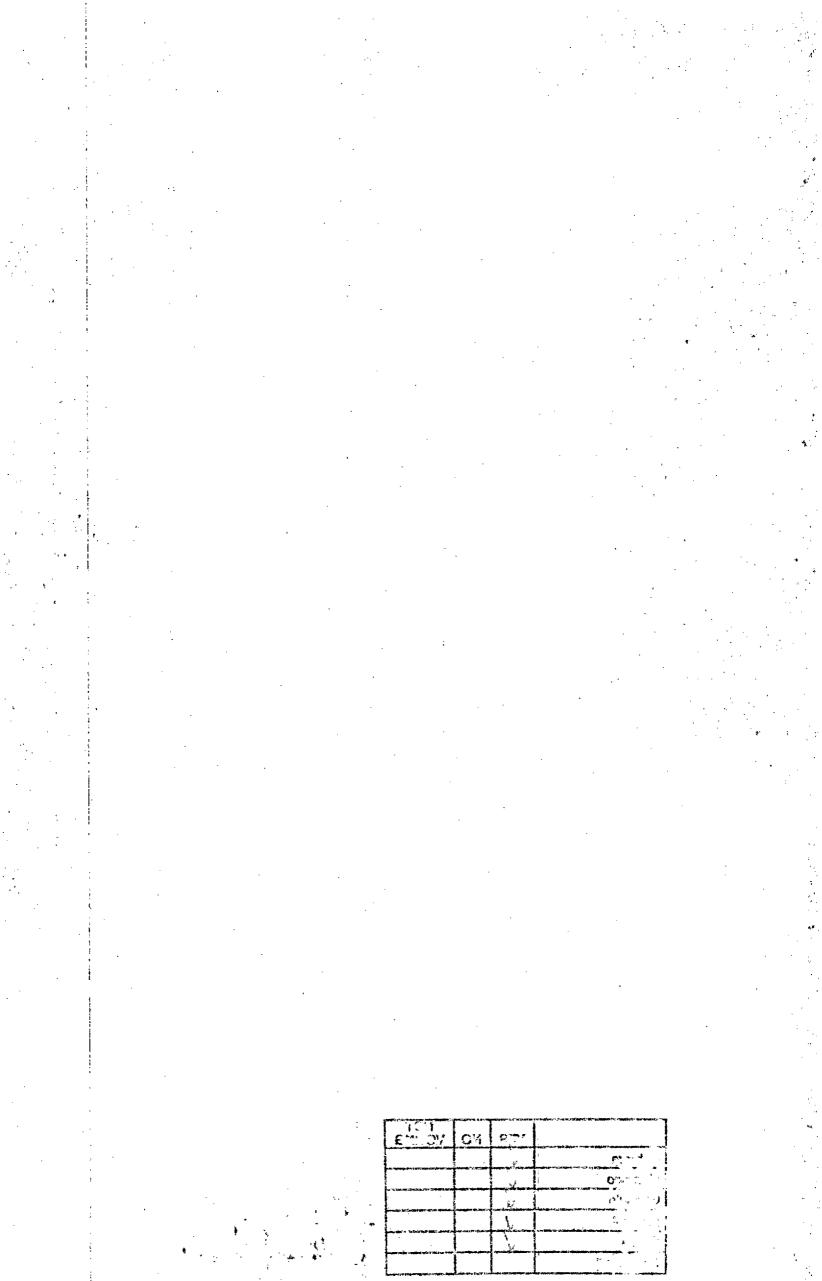

We are pleased to inform you that your 2021 Summer Food Service Program application has been approved, and you are now eligible to receive reimbursement for meal service. The 2021 funding approved for your organization is \$124,768.80. A copy of your approved Schedule C Menu and Pink Agreement will be mailed to your sponsorship.

As a reminder, area eligibility is good for 5 years. Those sites with current area eligibility are noted with an "A" on the Schedule A. Sites noted with an "E" will be required to submit the annual documentation required to obtain or renew site eligibility.

As a sub-recipient of New Jersey Department of Agriculture funds, it is imperative that you provide the above listed FAIN numbers, CFDA number, and Grant Period to your CPA. This requirement is in accordance with the Uniform Administrative Requirements, Costs Principles, and the Audit Requirements for Federal Awards.

The New Jersey Department of Education (NJDOE) has approved school district and charter school restricted and unrestricted indirect cost rate applications for the year 2020-2021 School year. If the NJDOE approved indirect cost rate is utilized, it must be documented and charged consistently across all programs.

If you have never received a negotiated indirect cost rate, you may elect to charge a rate of 10% of modified total direct costs indefinitely. If this election is made, you must use this rate consistently for all Federal Awards and all charges must be documented. If you have any questions, please our Division's fiscal office at 609-984-1439.

Each sponsor must ensure that they are maintaining a nonprofit food service operation and must restrict all income accrued from the Summer Food Service Program to use solely for the operation or improvement of the food service.

#### AUDIT REQUIREMENTS

The audit requirements for Program sponsors, pursuant to the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards and/or New Jersey OMB Circular 15-08, include the following:

Recipients whose funding is \$750,000 or more in state and/or federal financial assistance within their fiscal year must have a single audit performed in accordance with 2 CFR Part 200 Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards.

Recipients whose funding is less than \$750,000 but more than \$100,000 in state and/or federal financial assistance within their fiscal year must have either a financial statement audit performed in accordance with Government Auditing Standards (Yellow Book) or a program-specific audit performed in accordance with circular letter NJ 15-08-OMB. The type of Audit required is dependent upon the source of funding.

Recipients whose funding is less than \$100,000 in federal and/or state funding within their fiscal year are not required to have an audit performed.

The completed audit is due to the cognizant agency, the one which provided most of the funding, within 9 months of sponsor's fiscal year end. The audit must be performed by an independent CPA. Federal funds <u>cannot</u> be used to pay for any required audit.

State funds expended during the sponsor's fiscal year derived from a vendor relationship are not subject to audit requirements. Determination of a vendor relationship status of funds expended can only be made by the cognizant agency, in conjunction with the other funding agency or agencies if necessary.

Failure to comply with audit requirements may result in an over claim to sponsor's Program and/or a seriously deficient determination.

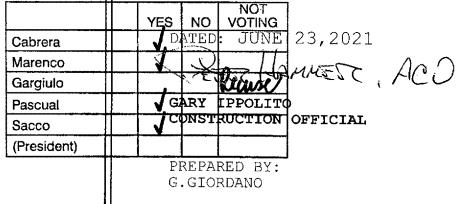

WHEREAS, the Commissioners of the Township of North Bergen recognize that handicapped drivers face unique difficulties in the location of parking spaces; and

WHEREAS, the Commissioners of the Township of North Bergen have been empowered by

N.J.S.A. 39:4-205 to restrict certain areas for handicapped parking; and

WHEREAS, Ordinance No. 503-93, Ordinance No. 1115-07, Ordinance No. 40-10 and Ordinance No. 203-13 establish the terms and conditions for handicapped spaces.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Township of North Bergen that:

Section I: One restricted handicapped parking space be and hereby is established in front of the residence of Lydia E. Cordero of 7604 Park Avenue Apt. #105, North Bergen, N.J. 07047.

Section 5: Any person who commits a violation of this ordinance shall be subject to a fine of at least \$300.00 and up to 90 days of Community Service on such terms and in such form as the Municipal Court Judge deems appropriate or any combination thereof. A separate offense shall be deemed committed on each day during or on which the violation continues.

Section 6: All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the inconsistency thereof.

# TOWNSHIP OF NORTH BERGEN HUDSON COUNTY, NEW JERSEY

# AN ORDINANCE PROVIDING FOR THE ZONING AND REGULATION OF CANNABIS PURSUANT TO THE NEW JERSEY CANNABIS REGULATORY, ENFORCEMENT ASSISTANCE, AND MARKETPLACE MODERNIZATION ACT, PL 2021, C. 16

# BE IT ORDAINED BY THE COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN, as follows:

# Section 1. <u>Background and Findings</u>

A. In 2020 New Jersey voters approved Public Question No. 1, which amended the State of New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age.

B. Public Question No. 1 was approved by the voters of the Township by a margin of 12,624 in favor and 7,144 opposed.

C. On February 22, 2021, Governor Murphy signed into law P.L. 2021, c.16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession.

D. The Act establishes six marketplace classes of licensed businesses, consisting of:

- 1. Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- 2. Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- 3. Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- 4. Class 4 Cannabis Distributor license, for businesses involved in transporting cannabis plants in bulk from one licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- 5. Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- 6. Class 6 Cannabis Delivery license, for businesses providing courier services for consumer purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of the purchased items to a consumer, and which service would include the ability of a consumer to make a purchase directly through the cannabis delivery service which would be presented by the delivery service for fulfillment by a retailer and then delivered to a consumer.

E. Section 3 of the Act defines a "cannabis establishment" as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer".

F. Section 31a of the Act authorizes municipalities to adopt by ordinance regulations governing the number of (1) cannabis establishments, (2) cannabis

distributors and (3) cannabis delivery services, except for the delivery of cannabis items and related supplies by a cannabis delivery service based and initiated from outside of the municipality.

G. Section 31a of the Act also authorizes municipalities to adopt by ordinance regulations governing the local licensing endorsement, location, manner and times of operation of cannabis establishments and cannabis distributors, and the location and manner of cannabis delivery services, and establishing civil penalties for the violation of any such regulations.

H. Section 31b of the Act authorizes municipalities to prohibit by ordinance the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality, except for the delivery of cannabis items and related supplies by a delivery service based and initiated from outside of the municipality.

I. Section 31b of the Act stipulates that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (i.e., by August 21, 2021). The failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones. At the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again, in 2026, have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis businesses already operating with appropriate approvals within the municipality.

J. Section 40 of the Act permits a municipality to adopt an ordinance imposing a transfer tax on the sale of cannabis or cannabis items by a cannabis establishment that is located in the municipality on receipts from the sale of cannabis by a cannabis cultivator to another cannabis cultivator; receipts from the sale of cannabis items from one cannabis establishment to another cannabis establishment; receipts from the retail sales of cannabis items by a cannabis retailer to retail consumers who are 21 years of age or older; or any combination thereof and to set its own rate or rates, but in no case exceeding: two percent of the receipts from each sale by a cannabis cultivator; two percent of the receipts from each sale by a cannabis manufacturer; one percent of the receipts from each sale by a cannabis manufacturer; one percent of the receipts from each sale by a cannabis manufacturer; one percent of the receipts from each sale by a cannabis manufacturer; one percent of the receipts from each sale by a cannabis manufacturer; one percent of the receipts from each sale by a cannabis manufacturer; one percent of the receipts from each sale by a cannabis manufacturer; one percent of the receipts from each sale by a cannabis manufacturer.

K. The Township has determined that it will allow all classes of business licenses set forth above, except cannabis delivery licenses. The Township will also prohibit cannabis consumption areas.

L. Due to the oversight and additional demands on public resources, the Township will require payment of municipal taxes to the maximum extent permissible under State law.

## Section 2. <u>Definitions</u>

A. "Alternative Treatment Center" or ATC means an organization issued a permit pursuant to the "Jake Honig Compassionate Use Medical Cannabis Act," P.L. 2009, c.307 (C.24:6I-1 et seq.) to operate as a medical cannabis cultivator, medical cannabis manufacturer, medical cannabis dispensary, or clinical registrant, as well as any alternative treatment center deemed pursuant to section 7 of that act (C.24:6I-7) to concurrently hold a medical cannabis cultivator permit, a medical cannabis manufacturer permit, and a medical cannabis dispensary permit.

"Cannabis" means all parts of the plant Cannabis Sativa L., whether B. growing or not, the seeds thereof, and every compound, manufacture, salt, derivative, mixture, or preparation of the plant or its seeds, except those containing resin extracted from the plant, which are cultivated and, when applicable, manufactured in accordance with P.L. 2016, c. 16 for use in cannabis products as set forth in the Act, but shall not include the weight of any other ingredient combined with cannabis to prepare topical or oral administrations, food, drink, or other product. "Cannabis" does not include: medical cannabis dispensed to registered qualifying patients pursuant to the "Jake Honig Compassionate Use Medical Cannabis Act," P.L. 2009, c.307 (C.24:6I-1 et seq.) and P.L. 2015, c.158 (C.18A:40-12.22 et seq.); marijuana as defined in N.J.S. 2C:35-2 and applied to any offense set forth in chapters 35, 35A, and 36 of Title 2C of the New Jersey Statutes, or P.L. 2001, c.114 (C.2C:35B-1 et seq.), or marihuana as defined in section 2 of P.L. 1970, c.226 (C.24:21-2) and applied to any offense set forth in the "New Jersey Controlled Dangerous Substances Act," P.L. 1970, c.226 (C.24:21-1 et seq.); or hemp or a hemp product cultivated, handled, processed, transported, or sold pursuant to the "New Jersey Hemp Farming Act," P.L. 2019, c.238 (C.4:28-6 et seq.).

C. "Cannabis consumption area" means, as further described in section 28 of P.L. 2019, c.153 (C.24:6I-21), a designated location operated by a licensed cannabis retailer or permit holder for dispensing medical cannabis, for which both a State and local endorsement has been obtained, that is either: (1) an indoor, structurally enclosed area of the cannabis retailer or permit holder that is separate from the area in which retail sales of cannabis items or the dispensing of medical cannabis occurs; or (2) an exterior structure on the same premises as the cannabis retailer or permit holder, either separate from or connected to the cannabis retailer or permit holder, at which cannabis items or medical cannabis either obtained from the retailer or permit holder, or brought by a person to the consumption area, may be consumed. D. "Cannabis cultivator" means any licensed person or entity that grows, cultivates, or produces cannabis in this State, and sells, and may transport, this cannabis to other cannabis cultivators, or usable cannabis to cannabis manufacturers, cannabis wholesalers, or cannabis retailers, but not to consumers.

E. "Cannabis delivery service" means any licensed person or entity that provides courier services for consumer purchases of cannabis items and related supplies fulfilled by a cannabis retailer in order to make deliveries of the cannabis items and related supplies to that consumer, and which services include the ability of a consumer to purchase the cannabis items directly through the cannabis delivery service, which after presenting the purchase order to the cannabis retailer for fulfillment, is delivered to that consumer.

F. "Cannabis distributor" means any licensed person or entity that transports cannabis in bulk intrastate from one licensed cannabis cultivator to another licensed cannabis cultivator, or transports cannabis items in bulk intrastate from any one class of licensed cannabis establishment to another class of licensed cannabis establishment, and may engage in the temporary storage of cannabis or cannabis items as necessary to carry out transportation activities.

G. "Cannabis establishment" means a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer.

H. "Cannabis manufacturer" means any licensed person or entity that processes cannabis items in this State by purchasing or otherwise obtaining usable cannabis, manufacturing, preparing, and packaging cannabis items, and selling, and optionally transporting, these items to other cannabis manufacturers, cannabis wholesalers, or cannabis retailers, but not to consumers.

I. "Cannabis retailer" means any licensed person or entity that purchases or otherwise obtains usable cannabis from cannabis cultivators and cannabis items from cannabis manufacturers or cannabis wholesalers, and sells these to consumers from a retail store, and may use a cannabis delivery service or a certified cannabis handler for the off-premises delivery of cannabis items and related supplies to consumers. A cannabis retailer shall also accept consumer purchases to be fulfilled from its retail store that are presented by a cannabis delivery service which will be delivered by the cannabis delivery service to that consumer.

J. "Cannabis wholesaler" means any licensed person or entity that purchases or otherwise obtains, stores, sells or otherwise transfers, and may transport, cannabis items for the purpose of resale or other transfer to either another cannabis wholesaler or to a cannabis retailer, but not to consumers.

K. "Committee" or "Cannabis Committee" means the Cannabis Committee established under Section 4 of this Ordinance.

L. "Medical Cannabis Dispensary" means a business licensed by the State of New Jersey to sell medical cannabis to registered qualifying patients and their authorized care givers. This term shall include the organization's officers, directors, board members, and employees.

M. "Person" means an individual or a corporation, association, firm, partnership, limited liability company or other legal entity.

N. "Township" means the Township of North Bergen.

# Section 3. Zoning Amendments

A. The Township's Zoning Ordinance, Article III is hereby amended and supplemented by the addition of new Section 3.5A), as follows:

## 3.5 A) Cannabis Uses Prohibited

All classes of licenses for cannabis establishments pertaining to adult use cannabis are prohibited from operating anywhere in the Township unless specifically set forth in this Ordinance and except for delivery of cannabis items and related supplies by a licensed cannabis delivery service based and initiated from a cannabis delivery service licensed outside the Township.

Cannabis delivery services and cannabis consumption areas are hereby designated a prohibited use in the Township.

B. The Township's Zoning Ordinance is hereby amended and supplemented by the addition of new Section 3.11, "Cannabis Establishments" as follows:

3.11 Cannabis Establishments

Cannabis establishments shall be permitted, pursuant to this Chapter, only if the following requirements are complied with:

a. The regulations of this Ordinance are subject to the enabling authority of the State of New Jersey and are subject to compliance with all statutes and/or regulations adopted by the State of New Jersey or its instrumentalities. If any provision of this Ordinance is inconsistent with the statutes and/or regulations of the State of New Jersey, the State statutes and/or regulations shall prevail.

b. Prior to the operation of any cannabis establishment or cannabis distributor, a permit or license must be obtained from the State of New Jersey and from the Township for applicable type(s) of licenses. No cannabis establishment or cannabis distributor shall be permitted to operate without State and Township permits or licenses, and in compliance with this Ordinance.

c. Permitted uses shall, at all times, comply with the terms and conditions of the licensee's cannabis establishment and cannabis distributor permits or licenses issued by the State of New Jersey and the Township.

d. No cannabis establishment or cannabis distributor shall be allowed as a Home Profession and Occupation.

e. No cannabis establishment or cannabis distributor shall be housed in a vehicle or any movable or mobile structure.

f. Odor. Cannabis establishments and distributors shall have equipment to mitigate odor. The building shall be equipped with a ventilation system with carbon filters sufficient in type and capacity to mitigate cannabis odors emanating from the interior of the premises.

g. Noise. Outside generators and other mechanical equipment used for any kind of power supply, cooling or ventilation shall be enclosed and have appropriate baffles, mufflers and/or other noise reduction systems to mitigate noise pollution.

h. Security. All cannabis establishments and cannabis distributors shall be secured in accordance with State of New Jersey statutes and regulations; shall have a round-the-clock video surveillance system, 365 days a year; and shall have trained security personnel onsite at all times during operating hours. The security video shall be maintained and available for review and down load by the Township for at least 90 days.

i. No cannabis establishment or distributor shall operate without opaque barriers to shield operations.

j. Hours. No cannabis retailer may open to customers for business before 8:00 a.m. or remain open to customers for business after 8:00 p.m.

k. Prohibited uses. Except as expressly permitted by this Ordinance, as well as any other activity involved in the cultivation, manufacture, processing, testing, dispensation, distribution and/or sale of cannabis, marijuana or cannabis products, are expressly prohibited as land uses or otherwise in the Township.

1. Number of Licenses. There shall be no more than two (2) cannabis retailer licenses issued or permitted in the Township.

m. Cannabis consumption areas or cannabis consumption lounges are expressly prohibited.

C. The Township's Zoning Ordinance, is hereby amended and supplemented by amending Article III, Establishment of Districts and District Regulations as follows:

Section 3.8 Commercial Districts

b. District C-2 Highway Commercial

2) Principal permitted uses to add:

Cannabis retailers licensed by the State of New Jersey and the Township provided that there shall be no more than two (2) cannabis retailers permitted in the C-2 District, one located north of  $43^{rd}$  Street and the other located south of  $43^{rd}$  Street provided that such cannabis retailer are not located within 1,000 feet of one another and shall not be located within 1,000 feet of any school.

# Section 5. License Applications, Renewals, Appeals

A. Applicants for a cannabis establishment or cannabis distributor or renewal thereof, shall furnish the following information to the Township Business Licensing Clerk:

- 1. The name and trade name of the applicant, address and contact phone numbers;
- 2. The names, addresses and phone numbers of all owners of the applicant owning 10% or more of the applicant. Where a person owning 10% or more of the applicant is itself a corporation, partnership, or other nonindividual, the 10% owners of that entity shall be provided. The disclosure shall be continued until names and addresses of every person exceeding the 10% ownership criteria is established;
- 3. An agent and address at which the applicant consents to service of process.
- 4. The address from which the business will be conducted;
- 5. Documentation reflecting the applicant has or will have the right to operate at the proposed location, such as a deed, lease or contract of sale;
- 6. Where the applicant is a corporation, documentation that the corporation is authorized to conduct business in the State of New Jersey;
- 7. The intended days per week and hours of operation of the business;
- 8. A demonstration the that the applicant meets the zoning requirements set forth in the Township's zoning ordinances, including as amended by this Ordinance;
- 9. The proximity of the business to any day care centers;
- 10. A demonstration that the applicant has or will receive all necessary approvals and licenses required from the State of New Jersey;
- 11. A demonstration that the applicant will satisfy all requirements set forth in Section 4 of this Ordinance;
- 12. The applicant's business plan, which shall include a demonstration of the applicant's financial resources and plan that will enable the applicant to effectuate the implantation and maintenance of operations;
- 13. Employment and business background of all owners identified in subsection A.2 of this Section;
- 14. Employment and business background of any employees the entity would like to submit at its discretion;
- 15. The applicant's security plan for operation, including consideration of employee safety and the safety of any person visiting or interacting with the applicant's business;
- 16. The applicants community engagement plan;
- 17. The applicant's Employee hiring plan; and
- 18. Any other information requested by the Cannabis Committee.

B. The form of application for a license and license renewal shall be prepared by the Township Attorney in consultation with the Chief of Police.

C. Applications shall be reviewed and evaluated by the Cannabis Committee, and the Cannabis Committee shall issue a recommendation to the Board of Commissioners where the Cannabis Committee finds that an application should be approved or conditionally approved.

D. Where the applicant has obtained a determination of local support from the Township, and provided all the information required by this Section in relation to that

request for local support had been provided, if there are no changed circumstances, there shall be a presumption that the application should be approved for licensure.

E. Where the Cannabis Committee recommends approval or conditional approval, the recommendation shall be presented to the Township Clerk for consideration by the Board of Commissioners as to whether a license should be granted, approved or conditionally approved, in the discretion of the Board of Commissioners.

F. When an application for a license is denied, the applicant may appeal, as provided in this subsection.

- 1. The appeal shall be filed in writing with the Business Licensing Clerk within 30 days of the date the Township mails notice of denial to the address provided in the application. In addition to the application on file with the Township, as part their appeal, the applicant may file with the Township Business Licensing Clerk any other documents and written argument the applicant wishes the Township Cannabis Committee to consider.
- 2. Provided a timely appeal is filed, the Cannabis Committee will consider the appeal based on the written record submitted by the applicant.
- 3. Within 30 days following the submission of the applicant's appeal, the Cannabis Committee shall issue a written decision, which shall be final.

# Section 6. License Issuance, Duration and Renewal

A. Where an application for a license has been approved by the Board of Commissioners, and all conditions have been satisfied, the Business Licensing Clerk will issue the applicable license.

B. Licenses will be valid for one year from the date of issuance.

C. In order to avoid a lapse in a license, licensees shall submit applications for license renewals at least 30 days prior to the expiration of their license.

## Section 7. Local Support Determinations

A. Where an applicant requires a determination of local support from the Township for State licensing pursuant to the Act, the applicant may file an application with the Cannabis Committee, providing the information required in Section 5, to the extent same is practically available.

B. The request for local support will be evaluated by the Cannabis Committee, and the Cannabis Committee will make a recommendation to the Board of Commissioners where the Cannabis Committee finds that a determination of local support should be issued.

C. Where the Cannabis Committee recommends the issuance of local support, the recommendation shall be presented to the Township Clerk for consideration by the Board of Commissioners as to whether local support should be issued.

D. The appeal process set forth in Section 5.E shall be followed in the event the Cannabis Committee determines local support should be denied.

#### Section 8. Fees

B.

A. The fees for initial license applications by applicants shall be as follows:

1.	Cannabis Cultivator:	\$20,000
2.	Cannabis Manufacturer:	\$15,000
3.	Cannabis Retailer:	\$15,000
4.	Cannabis Wholesaler:	\$10,000
5.	Cannabis Distributor:	\$10,000
The	fees for renewal licenses for appl	licants shall be as follows:
1.	Cannabis Cultivator:	\$10,000
2.	Cannabis Manufacturer:	\$7,500
3.	Cannabis Retailer:	\$7,500

4. Cannabis Wholesaler: \$5,000

5. Cannabis Distributor: \$5,000

C. Fees shall be payable upon the applicant receiving State approval.

# Section 9. Consent to Entry and Search

The filing of an application, and acceptance and use of a license issued by the Township, shall be deemed consent by the licensee to allow the Township's entry into and upon the licensed premises, and to allow the Township's inspection and search of licensed premises and business records, in order for the Township to determine that the licensee is operating in compliance with this Ordinance and State law.

# Section 10. License Suspension and Revocation

A. Licenses issued hereunder may be revoked or suspended by the Cannabis Committee if the licensee has, based on the determination of the Cannabis Committee:

1. Violated any Township ordinance, state, or federal law, the violation of which reflects unfavorably on the fitness of the licensee to hold a license, or which is a violation of any cannabis related State law, rule or regulation, or this Ordinance.

B. Whenever the holder of more than one license shall have one such license revoked for the violation of this Ordinance, the Township Business Licensing Clerk shall have the right to also revoke (1) all other license(s) held by the same person; and (2) licenses held by other persons, which have at least one common owner identified as required by Section 5.A.2.

C. Prior to revocation, the licensee will be given 15 days' written notice of the proposed act to be taken and the reasons therefore, except that suspensions may be immediate where the Chief of Police determines that the acts or status of the cannabis establishment or cannabis distributor constitutes a danger to or jeopardizes the public safety.

D. Revocation or suspension of a license may be appealed in writing to the Cannabis Committee within 30 days after the notice of revocation or suspension is mailed

to the licensee's address on file with the Township. The same procedure set forth in Section 5.E shall apply to a license revocation or suspension.

# Section 11. Public Nuisance Declared.

Operation of any prohibited or unpermitted cannabis business establishment within the municipality in violation of the provisions of this Ordinance is hereby declared a public nuisance and shall be abated pursuant to all available remedies. Nothing in this Section shall limit the Township's available rights and recourse under other sections of this Ordinance.

# Section 12. Transfers of Licenses Prohibited

A. No license may be sold, assigned, encumbered or otherwise transferred, except if the following criteria are met:

- 1. The proposed licensee is another wholly owned business of the licensee;
- 2. The sale, assignment, encumbrance, or transfer complies with New Jersey law and the licensee's New Jersey cannabis license;
- 3. The sale, assignment, encumbrance, or transfer approval shall be at the sole discretion of the Township Cannabis Committee and may only be effective upon written authorization issued by the Township Business Licensing Clerk.

B. The Township may require any proposed transferee or person holding an encumbrance to file a new application as per Section 5 of this Ordinance.

C. Any request for a license transfer shall be accompanied by a fee of \$3,000. If a new application is required, the fees in Section 8 shall control, with a credit for any fee paid pursuant to this Section.

# Section 13. Investigation and Enforcement

A. Township personnel may, from time to time, conduct investigations to determine that any licensee is operating within the Township in compliance with the provisions of this Ordinance and State law.

B. Any Township business license inspector, police officer, or health inspector may enforce the provisions of this Ordinance and issue summonses under this Ordinance.

# Section 14. Taxes

A. A transfer tax is hereby imposed on the sale of cannabis or cannabis items by cannabis establishments located in the Township. The tax is imposed on:

1. Receipts from the sale of cannabis by a cannabis cultivator to another cannabis cultivator;

- 2. Receipts from the sale of cannabis items from one cannabis establishment to another cannabis establishment;
- 3. Receipts from the retail sales of cannabis items by a cannabis retailer to retail consumers who are 21 years of age or older; and
- 4. Any combination of subsections 1 through 3 of this subsection A.
- B. The tax rates shall be as follows:
- 1. Two percent (2%) of the receipts from each sale by a cannabis cultivator;
- 2. Two percent (2%) of the receipts from each sale by a cannabis manufacturer;
- 3. One percent (1%) of the receipts from each sale by a cannabis wholesaler; and
- 4. Two percent (2%) of the receipts from each sale by a cannabis retailer.

C. A user tax is hereby imposed, at the transfer tax rates set forth in subsection B of this Section, on any concurrent license holder, as permitted by section 33 of P.L. 2021, c.16 (C.24:6I-46), operating more than one cannabis establishment. The user tax is imposed on the value of each transfer or use of cannabis or cannabis items not otherwise subject to the transfer tax imposed pursuant to subsections A and B of this Section, from any license holder's establishment that is located in the Township to any of the other license holder's establishments, whether located in the Township or another municipality.

D. The Chief Financial Officer shall collect and administer any transfer tax or user tax imposed by this Ordinance pursuant to this section and in accordance with N.J.S.A. 40:48I-1. The Township will enforce the payment of delinquent taxes or transfer fees imposed by this Ordinance in the same manner as provided for Township real property taxes.

Section 15. <u>Penalties</u> In addition to the revocation and suspension provisions in this Ordinance, any person who shall violate any of the provisions of this Ordinance shall upon conviction thereof be punished by a fine not to exceed two thousand dollars (\$2,000).

# THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN DO ORDAIN:

Section 1: Section 11.0 of Ordinance No. 710-49, as amended by Ordinance No.

127-86 and Ordinance No. 137-12, among other ordinances, is further amended as follows:

Trucks of over five tons gross weight (10,000 lbs.) are hereby excluded from the following streets, or parts of streets, except for the pick-up or delivery of materials to or from residents or businesses located on such parts of the below streets:

49<sup>th</sup> Street between Tonnelle Avenue and Dell Avenue 48<sup>th</sup> Street between Tonnelle Avenue and Dell Avenue 47<sup>th</sup> Street between Tonnelle Avenue and Dell Avenue 46<sup>th</sup> Street between Tonnelle Avenue and Dell Avenue 45<sup>th</sup> Street between Tonnelle Avenue and Dell Avenue 44<sup>th</sup> Street between Tonnelle Avenue and Dell Avenue

Section 2: Penalty and Violation

Any person who violates this Ordinance shall be subject to a fine of not less than \$100.00 nor more than \$500.00 in the discretion of the Municipal Court Judge.

Section 3: All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed as to the inconsistency thereof.

Section 4: If any part or parts of this Ordinance are for any reason held to be invalid, such holding shall not affect the validity of the remaining portions of this Ordinance.

Section 5: This Ordinance shall take effect upon approval by the Commissioner of Transportation of the State of New Jersey, provided that this Ordinance shall not take effect prior to the 20<sup>th</sup> day following final adoption.

WHEREAS, the Commissioners of the Township of North Bergen recognize that handicapped drivers face unique difficulties in the location of parking spaces; and

WHEREAS, the Commissioners of the Township of North Bergen have been empowered by

N.J.S.A. 39:4-205 to restrict certain areas for handicapped parking; and

WHEREAS, Ordinance No. 503-93, Ordinance No. 1115-07, Ordinance No. 40-10 and Ordinance No. 203-13 establish the terms and conditions for handicapped spaces.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Township of North Bergen that:

Section I: One restricted handicapped parking space be and hereby is established in front of the residence of Alisson K. Telon of 715 – 85<sup>th</sup> Street 1<sup>st</sup> Flr., Jacqueline Boros of 1706 – 47<sup>th</sup> Street, Angel Castro of 1435 – 37<sup>th</sup> Street Apt. #1, James T. Damato of 6917 Tonnelle Avenue, and Mercedes Perez of 809 – 91<sup>st</sup> Street Apt. A, North Bergen, N.J. 07047.

Section 2: The aforesaid space shall be used only by a motor vehicle displaying a permit issued by the North Bergen Police Department identifying the location of said handicapped parking space and the specific motor vehicle entitled to use same.

Section 3: The North Bergen Department of Public Works shall establish a restricted parking zone at the above location and shall erect a sign with the legend "Handicapped Parking for Resident Vehicle License Plate Number "3 1 5 6 H G" for Alisson K. Telon, "4 8 1 6 H H" for Jacquelin A. Boros, "3 1 4 4 H G" for Angel Castro, "M W M 9 1 K"

Section 4: This ordinance shall remain in effect for two (2) years ending December  $31^{st}$  of the second year from its effective date at which point it will expire and be of no further force or effect unless it is renewed for a further two (2) year period by formal resolution of the Board of Commissioners in accordance with Ordinance Nos. 1115-07 and 40-10.

Section 5: Any person who commits a violation of this ordinance shall be subject to a fine of at least \$300.00 and up to 90 days of Community Service on such terms and in such form as the Municipal Court Judge deems appropriate or any combination thereof. A separate offense shall be deemed committed on each day during or on which the violation continues.

Section 6: All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the inconsistency thereof.

Section 7: If any part or parts of this ordinance are for any reason held to be invalid, such holding shall not affect the validity of the remaining portions of this ordinance.
