# Proclamation

WHEREAS, Rodriguez has been a member of the NBPD for two and a half years. He has spent those years assigned to the Patrol Division in Squad 3. Officer Rodriguez was selected as Officer of the Month for January and May of 2020; and

WHEREAS, In January, Officer Rodriguez was patrolling the motels on Tonnelle Avenue. He noticed a vehicle fitting the description on an officer safety TRAK Alert; and

WHEREAS, Rodriguez ran the license plate and confirmed it belonged to an individual who was believed to be suicidal and possibly in possession of a firearm. The individual was also wanted by other agencies; and

WHEREAS, Rodriguez entered the motel office and confirmed that this individual had checked into the motel and was in fact inside the room. The individual was taken into custody without incident. According to the NBPD, Rodriguez exhibited vigilance and removed a potentially dangerous party off the streets; and

WHEREAS, In May, Rodriguez responded to an accident in which two males fled the scene. The video showed one of the men was in possession of a handgun. Rodriguez canvassed the area and observed two males matching the description. The men separated and were stopped by officers; and

WHEREAS, According to the NBPD, Rodriguez used police investigative techniques and obtained further information from the suspect. The suspect admitted to having a handgun, but stated it was a toy gun. The suspect pointed out where he discarded the handgun. It was located and collected for evidence. The handgun was determined to have been a CO2 airgun; and

WHEREAS, Rodriguez is easer and motivated, according to the NBPD. In the short time he has been an officer, he has secured a position as a Field Training Officer (FTO); and

NOW, THEREFORE, BE IT RESOLVED that NICHOLAS J. SACCO, MAYOR OF THE TOWNSHIP OF NORTH BERGEN, and the entire Board of Commissioners, do hereby declare the respect and admiration to Police Officer Richard Rodriguez. 

# Proclamation

WHEREAS, there were 585 motor vehicle fatalities in New Jersey in 2020; and

WHEREAS, approximately 40% of the motor vehicle occupants killed in traffic crashes were not wearing a seat belt; and

WHEREAS, use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle crash; and

WHEREAS, the National Highway Traffic Safety Administration estimates that 135,000 lives were saved by safety belt usage nationally between 1975–2000; and

WHEREAS, the State of New Jersey will participate in the nationwide *Click It or Ticket* seat belt mobilization from May 24 – June 6, 2021 in an effort to raise awareness and increase seat belt usage through a combination of high visibility enforcement and public education; and

WHEREAS, the Division of Highway Traffic Safety has set a goal of increasing the seat belt usage rate in the state from the current level of 90.23% to 93%; and

WHEREAS, a further increase in seat belt usage in New Jersey will save lives on our roadways; and

NOW, THEREFORE, BE IT RESOLVED that NICHOLAS J. SACCO, MAYOR OF THE TOWNSHIP OF NORTH BERGEN, and the entire Board of Commissioners, do bereby declare their support for the Click It or Ticket Seat Belt Mobilization both locally and nationally from May 24 – June 6, 2021 and pledges to increase awareness of the mobilization and the benefits of seat belt use.

ORDINANCE APPROPRIATING \$77,000.00 FROM THE CAPITAL RESERVE ACCOUNT FOR FUTURE IMPROVEMENTS FOR THE PURPOSE OF VARIOUS STREET AND SEWER IMPROVEMENTS AND BY THE TOWNSHIP OF NORTH BERGEN, IN THE COUNTY OF HUDSON, NEW JERSEY.

BE IT ORDAINED BY THE TOWNSHIP BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN, IN THE COUNTY OF HUDSON, NEW JERSEY AS FOLLOWS:

Section 1. \$77,000.00 is hereby appropriated from the Capital Reserve Account for Future Improvements for the purpose of various street and sewer improvements, including all work and materials necessary therefor and incidental thereto in and by the Township of North Bergen, in the County of Hudson, New Jersey (the "Township").

The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 1: Section 5.01 of Ordinance No. 710-49, as amended, shall be further amended as follows: The following intersections are deemed to be of particular hazard and are hereby designated as points at which the Traffic Engineer shall erect stop signs in the following manner, to wit:

#### AN ORDINANCE ESTABLISHING A RESTRICTED PARKING SPACE FOR USE BY THE HANDICAPPED

Carmen Diaz-Grainger 7612 Park Ave. Apt. #E5 North Bergen, NJ 07047

WHEREAS, the Commissioners of the Township of North Bergen recognize that handicapped drivers face unique difficulties in the location of parking spaces; and

WHEREAS, the Commissioners of the Township of North Bergen have been empowered by

N.J.S.A. 39:4-205 to restrict certain areas for handicapped parking; and

WHEREAS, Ordinance No. 503-93, Ordinance No. 1115-07, Ordinance No. 40-10 and Ordinance No. 203-13 establish the terms and conditions for handicapped spaces.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Township of North Bergen that:

Section I: One restricted handicapped parking space be and hereby is established in front of the residence of Carmen Diaz-Grainger of 7612 Park Avenue Apt. #E5, North Bergen, N.J. 07047.

Section 2: The aforesaid space shall be used only by a motor vehicle displaying a permit issued by the North Bergen Police Department identifying the location of said handicapped parking space and the specific motor vehicle entitled to use same.

Section 3: The North Bergen Department of Public Works shall establish a restricted parking zone at the above location and shall erect a sign with the legend "Handicapped Parking for Resident Vehicle License Plate Number "E 8 6 M Y K" for Carmen Diaz-Grainger, and this Ordinance Number.

Section 4: This ordinance shall remain in effect for two (2) years ending December  $31^{st}$  of the second year from its effective date at which point it will expire and be of no further force or effect unless it is renewed for a further two (2) year period by formal resolution of the Board of Commissioners in accordance with Ordinance Nos. 1115-07 and 40-10.

Section 5: Any person who commits a violation of this ordinance shall be subject to a fine of at least \$300.00 and up to 90 days of Community Service on such terms and in such form as the Municipal Court Judge deems appropriate or any combination thereof. A separate offense shall be deemed committed on each day during or on which the violation continues.

Section 6: All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the inconsistency thereof.

Section 7: If any part or parts of this ordinance are for any reason held to be invalid, such holding shall not affect the validity of the remaining portions of this ordinance.

Section 8: This ordinance shall take effect upon adoption and publication as required by law.
